**INVITATION TO BIDS**

1. **Evacuee Trust Property Board (ETPB)** invites sealed bids under the **Single Stage One Envelope Procedure** from reputed firms/ companies having at least three (03) years of experience in delivering event security services for Government entities. The required services relate to the festivals of Shrines scheduled to be held in November 2025 on the eve of 556<sup>th</sup> Birthday of Baba Guru Nanak Dev Ji, as tabulated below.
2. A complete set of Bidding Documents may be obtained by an interested and eligible bidder on submission of a written application on the firm's letterhead, along with an attested copy of CNIC, proof of inclusion in the ATL of FBR, and documentary evidence of relevant experience. The documents will be issued against a non-refundable fee of Rs. 3,000/- per event from the office of the undersigned during office hours up to **23-10-2025**. Bidding Documents shall be issued only to the proprietor of the firm or to a legally authorized representative holding a duly registered/ attested Power of Attorney.
3. All bids must be accompanied by a Bid Security in the form of a Call Deposit Receipt (CDR) issued in the name of the Evacuee Trust Property Board, Lahore, clearly bearing the Firm/ Company's name, from any Scheduled Bank of Pakistan. The bids, sealed in an envelope, shall be dropped in the tender box placed in the office of the undersigned on **24-10-2025** before **02:00 PM**. The same will be opened on the same day at **02:30 PM** in the presence of bidders' representatives who choose to attend, at the same address.

**Terms & Conditions:**

- Bidding Documents shall neither be sold/ issued after the closing date nor dispatched through post or email.
- In case of a public holiday, the receipt and opening of bids shall be carried out on the next working day at the same time and venue.
- The Invitation to Bids is also available on the PPRA and the ETPB website ([www.etpb.gov.pk](http://www.etpb.gov.pk)).
- If the bid amount of the successful bidder is found to be seriously unbalanced in relation to the estimated amount, the bidder shall be required to furnish an additional Performance Security equal to the difference between the estimated cost and the total bid amount, in the form of a Bank Guarantee from any Scheduled Bank of Pakistan or an Insurance Bond issued by an Insurance Company having an "AA" Rating.
- The Department reserves the right to inspect the warehouse/ store of the participating firm/ company to verify that it possesses adequate materials and resources to deliver the security services in accordance with the requirements of the Bidding Documents.
- The Department reserves the right to reject any or all bids/ proposals at any time prior to acceptance, under Rule 33(1) of the Public Procurement Rules, 2004.
- The number of days and quantity of Security equipment may increase or decrease subject to requirement.
